How Consignment Works at Home Treasures Market Place Inside the Carson Mall

Thank you for considering **Home Treasures Market Place** to consign and sell your items. Consignment is a practical, “green” way to recycle your treasures . . . and recover some of your original investment! Here is how we work together to help insure your experience is successful and profitable.

Before We Enter Into a Consignment Agreement

- We only sell items that are in excellent/good condition, clean and with up-to-date styles; in short . . . furnishings you would be proud to have in your home.
- Ideal consignment items for **Home Treasures Market Place** are home furnishings such as coffee tables, end tables, armoires, dining room sets, hutches, wall hangings, and any other home décor that you might have. It’s always worth asking us.
- We would like to see photos of your furnishings. Please email us at hometreasuresnv@gmail.com or bring the photos to our store. We will need to know if the items have been in a smoke and/or pet environment, so that we may share that with our customers.
- A sampling of the items we do not accept: mattresses, exercise equipment, sporting goods, luggage, appliances, linens, craft items, clothing, pianos, organs, furniture that needs repair and items that are dirty.
- Together, we’ll develop a selling price based on factors such as original price, age, condition and our research and knowledge of the value of your item.

Once We Agree to Work Together to Sell Your Item(s)

- First step is to enter into a simple written Agreement outlining our arrangement and each party’s responsibilities.
- In respect for your time – and so that we can give you proper attention – we accept consignments by appointment only. Please call us at 775-883-4260.
- We encourage you to enter as many items as you wish into our selling system, but we do have a limit of 15 items per week per consignor unless prior arrangements have been made.
- It is your responsibility to deliver accepted consignment items to our door (please bring a helper if necessary). We then move and display your items within our store.
- You are not charged for any advertising, overhead, credit card fees, etc. You only pay us the agreed upon percentage of the agreed upon selling price.

Our 90-Day Selling Period

- Our consignment period is 90 days and during this time, you may not sell your item(s) via another method while under contract with Home Treasures.
- We start with a mutually agreed upon selling price for each item. If the item does not sell in the first 30 days, it will be discounted as follows unless you specify that you do not want a specific item(s) discounted.
 - 01-30 days – Agreed upon selling price (For example: \$100)
 - 31-60 days – 10% discount to the buyer (For example: \$90)
 - 61-90 days – an additional 10% discount to the buyer (For example: \$81)
- Whatever the final selling price, you receive 50% and Home Treasures retains 50%.
- At the end of the 90-day consignment period, any unsold items must be picked up within 7 days. Please bring a helper to assist you and let us know when you’re coming so that we can have your item(s) ready. Items not picked up within 7 days of your consignment end date become the property of Home Treasures.
